




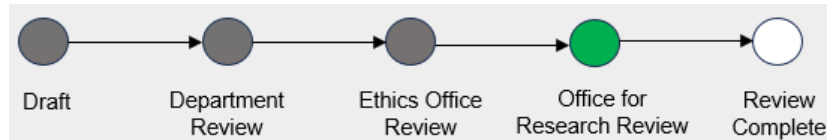
Ethics Office Review: Response Pending

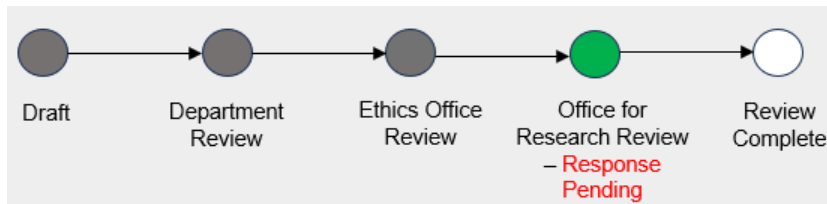
Office for Research Review

The Office has completed their review and is preparing to submit their determination of the disclosure



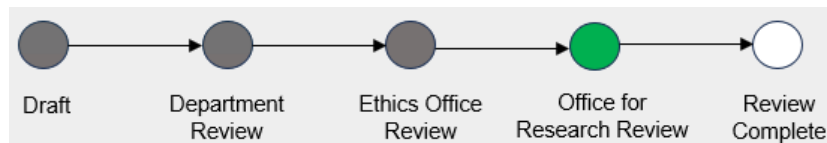
Office for Research Review: Response Pending

Scheduled for Meeting

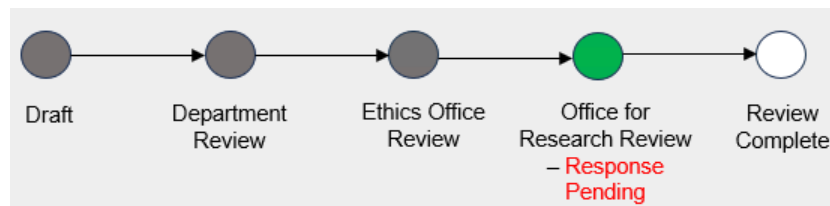

# eCOI+ Workflow and States Quick Guide



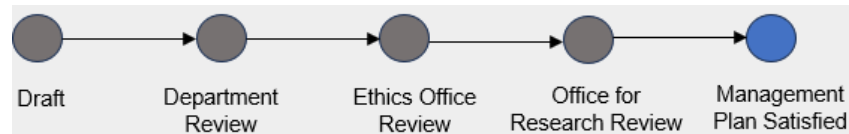
Under Management Plan

Management plan has been followed for full duration of study/ study has been closed.



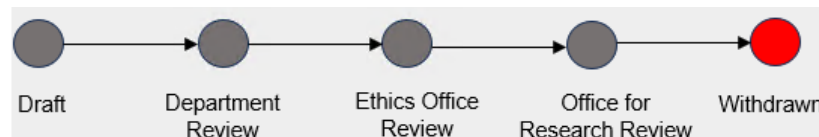
Denied by Ethics Office
