1 PURPOSE:

- 1.1 This procedure establishes the process to remove an IRB member.
- 1.2 The process begins when an IRB member resigns or is removed from one or more IRBs. This procedure applies if an individual is a member of more than one IRB and is being removed from some but not all IRBs.
- 1.3 The process ends when the IRB registration is updated.

2 REVISIONS FROM PREVIOUS VERSION:

3 POLICY:

- 3.1 The <u>Institutional Official (IO)</u> or designee may remove IRB members, alternate members, IRB chairs, and, if used, other officers (e.g., vice chairs) with consultation from the, HRPP Director, and IRB chair(s).
 - 3.1.1 Removal of members from the IRB for cause (such as breach of confidentiality, non-compliance, etc.) may not be delegated.
- 3.2 IRB rosters are maintained using 2.306 (HRP-601) DATABASE IRB Committee Member Profile (in eIRB+).

4 RESPONSIBILITIES:

4.1 HRPP staff members carry out these procedures.

5 PROCEDURE:

- 5.1 Remove individual's privileges from committee membership.
- 5.2 Edit the individual's status in 2.306 (HRP-601) DATABASE IRB Committee Member Profile (in eIRB+).
- 5.3 Complete 2.201 (HRP-304) WORKSHEET IRB Composition to ensure that the IRB is appropriately constituted.
 - 5.3.1 If not, identify one or more replacement members and follow 2.003 (HRP-082) SOP IRB Membership Addition.
- 5.4 Prepare 2.304 (HRP-561) LETTER IRB Thank You or equivalent, have it signed by the <u>IO</u> or designee and send to the individual.
- 5.5 Update the registration of all affected IRBs.¹
- 5.6 File:
 - 5.6.1 2.306 (HRP-601) DATABASE IRB Committee Member Profile (in eIRB+).
 - 5.6.2 2.304 (HRP-561) LETTER IRB Thank You or equivalent.
- 5.7 Direct IT to remove an individual's "Committee Member" role in the system.
 - 5.7.1 eIRB+ automatically updates the database.
